Why?	Financial companies choose how they share your personal information. Federal law give consumers the right to limit some but not all sharing. Federal law also requires us to tell you how we collect, share, and protect your personal information. Please read this notice carefully to understand what we do.
What?	<p>The types of personal information we collect and share depend on the product or service you have with us. This information can include:</p> <ul style="list-style-type: none"> Registration Information: This is the information you provide us on applications and through other means as part of the process of your registration for our services. This can include your name, mailing address, e-mail address, and other demographic information. Transaction and Experience Information: This includes information about your transactions and account experience, as well as information about our communications with you. Information from Outside Sources: This could include information we receive regarding your employment, credit, or other relationships.
How?	All financial companies need to share customers’ personal information to run their everyday business. In the section below we list the reasons financial companies can share their customers’ personal information; the reason Iontuition, Inc. chooses to share; and whether you can limit this sharing.

How does Iontuition, Inc. collect my personal information?	<p>We collect your personal information, for example, when you:</p> <ul style="list-style-type: none"> • Make a payment on your income share agreement • Provide us with documentation relating to your income share agreement • Apply for deferment or make other requests relating to your income share agreement • Give us your contact information <p>We also collect your personal information from others, such as credit bureaus, affiliates, or other companies.</p>
Why can't I limit all sharing	<p>Federal law gives you the right to limit only:</p> <ul style="list-style-type: none"> • Sharing for affiliate's everyday purposes – information about your creditworthiness • Affiliates from using your information to market to you • Sharing for nonaffiliates to market to you <p>State laws and individual companies may give you additional rights to limit sharing.</p>

Nonaffiliates	<p>Companies not related by common ownership or control. They can be financial and nonfinancial companies.</p> <p>Nonaffiliates we share with include service providers such as data processors, database providers, and others.</p> <p>Nonaffiliates we share information with include, but is not limited to:</p> <ul style="list-style-type: none"> • MentorWorks Education Capital, LLC
